Date	Issue	Action
June 29, 2018	China 301 (List 2)	Deadline to request to appear at the public hearing. Request must include a summary of testimony and may be accompanied by a pre-hearing submission.
June 29, 2018	Auto 232	Public comments due. Deadline to request to appear at the public hearing and to submit a summary of expected testimony.
July 6, 2018	China 301 (List 1)	25% duty effective on List 1 products
July 10, 2018	China 301 (List 3)	USTR issued proposed list of \$200 billion worth of Chinese products subject to 10% tariffs (List 3)
July 13, 2018	Auto 232	Due date for rebuttal comments submitted in response to any comments filed on or before June 29, 2018.
July 19 & 20, 2018	Auto 232	Public hearing in Washington, D.C.
July 23, 2018	China 301 (List 2)	Due date for submission of written comments
July 24, 2018	China 301 (List 2)	Public hearing in Washington, D.C.
July 31, 2018	China 301 (List 2)	Due date for submission of post-hearing rebuttal comments
August 1, 2018	China 301 (List 3)	USTR releases a notice announcing a possible increase in Section 301 List 3 tariff rates from 10% to 25%. Some List 3 deadlines are extended.
August 13, 2018	China 301 (List 3)	Due date for filing requests to appear and a summary of expected testimony at the public hearing, and for filing pre-hearing submissions. (extended deadline - previously July 27, 2018)
August 20-23	China 301 (List 3)	Public hearing in Washington, D.C.
August 23, 2018	China 301 (List 2)	25% duty effective on List 2 products
September 6, 2018	China 301 (List 3)	Due date for submission of written comments. (extended deadline - previously August 17, 2018)
September 6, 2018	China 301 (List 3)	Deadline for submission of post-hearing rebuttal comments (extended deadline - previously August 30, 2018)
September 24, 2018	China 301 (List 3)	10% duty effective on List 3 products
October 9, 2018	China 301 (List 1)	Deadline for product-specific requests for exclusion
December 18, 2018	China 301 (List 2)	Deadline for product-specific requests for exclusion
January 1, 2019	China 310 (List 3)	25% duty effective on List 3 products
Within 14 days after a request for exclusion is posted on docket	China 301 (List 1)	Deadline for responses to requests for product-specific exclusion
Within 7 days after the close of response period	China 301 (List 1)	Deadline for replies to responses filed during the 14-day response period
TBD	China 301 (List 3)	Deadline for product-specific requests for exclusion
